III. MINUTES

Ted Thoman made a motion to approve the December 17, 2015 Board of Directors & ACC Meeting minutes and Synopsis Minutes as written. Ray Dempsey seconded the motion. All in favor, the motion passed.

a. Violation Process

- Times frames for remedy – The Board discussed the time frames for various types of violations and reduced the time to remedy on three deed restriction violations.
- Putting \$150 legal fee cost for presuit mediation letter on homeowner ledger – A motion was made and seconded to apply violation legal fees to homeowners' ledgers. All in favor the motion passed.
- Review Letters – The second and final violation letter will be updated to include verbiage to advise owners that the next step is a presuit mediation letter and the legal fee for that will be added to their assessment account until it is paid.

b. Land Use – A meeting with Land Use Attorney Judy James was held giving her the direction to:

- Find out the County requirements to extend the sidewalk on the east side of Providence Run between Camden Apartments and the existing sidewalk behind Portsmouth
- See if the north side of the Tot Lot could be cleaned out for a walking trail and to allow for the expansion of the entrance/exit to the Tot Lot
- Explore option to create parking spaces in the 4 acres of green space at Providence Run.

c. Board Certification Classes – A Board Certification Class to be held at Greenacre Properties on February 12.

d. Resignation – Jan Washington – A motion was made and seconded to accept Jan Washington's resignation from the Board or Directors. All in favor the motion passed.


V. ADJOURNMENT
